WHEREAS, Declarant is the "Declarant" under that certain Declaration of Covenants, Conditions, and Restrictions for The Legacy at Jordan Lake recorded in the office of the Register of Deeds of Chatham County, North Carolina, in Book 1252, Page 524, as amended, supplemented, assigned or otherwise modified by instruments recorded in Book 1299, Page 789; Book 1311, Page 1090; Book 1375, Page 196; Book 1444, Page 400; Book 1490, Page 652; Book 1597, Page 165; Book 1643, Page 829; Book 1643, Page 860; Book 1727, Page 1; Book 1739, Page 362; Book 1739, Page 386; Book 1739, Page 390; and Book 1818, Page 686, all recorded in the office of the Register of Deeds of Chatham County, North Carolina (collectively, the "Declaration") (capitalized terms used in this Supplemental Declaration and not otherwise defined herein shall have the same meanings as set forth in the Declaration); and

WHEREAS, pursuant to the terms of Section 7.1 of the Declaration, the Declarant may submit to the terms of the Declaration all or any portion of certain additional property described on Exhibit "B" to the Declaration; and

WHEREAS, Declarant is the owner of the real property described on Exhibit "A" attached hereto ("Additional Property"); and

WHEREAS, the Additional Property is a portion of that property described on Exhibit "B" to the Declaration; and

WHEREAS, the Declarant desires to submit the Additional Property to the terms of the Declaration;

NOW, THEREFORE, pursuant to the powers retained by Declarant under the Declaration, Declarant hereby subjects the Additional Property described on Exhibit "A" hereof to the provisions of the Declaration and this Supplemental Declaration, both of which shall apply to such property. The Additional Property shall be sold, transferred, used, conveyed, occupied and mortgaged or otherwise encumbered pursuant to the provisions of this Supplemental Declaration and the Declaration, both of which shall run with the title to such property and shall be binding upon all persons having any right, title, or any interest in such property, their respective heirs, legal representatives, successors, successors-in-title and assigns. The provisions of this Supplemental Declaration shall be binding upon them in accordance with the terms of the Declaration.

FURTHER, pursuant to the powers retained by Declarant under the Declaration, including but not limited to Section 7.4 of the Declaration, and notwithstanding any contrary provision contained in the Declaration and this Supplemental Declaration, Declarant hereby declares that the Additional Property described on Exhibit "A" attached hereto shall not be subject to the Design Guidelines or Architectural and Site Design Guidelines attached to and recorded with the original Declaration recorded in the office of the Register of Deeds of Chatham County, North Carolina, in Book 1252, Page 524. The Additional Property described on Exhibit "A" hereto shall be subject to Design Guidelines adopted by and made applicable to the Additional Property by the ARB pursuant to the terms and conditions of Article 9 of Declaration, as the same may be amended from time to time pursuant to the authority reserved to the ARB in Article 9 of the Declaration.

Except as specifically modified and amended hereby, the Declaration and all terms thereof shall remain in full force and effect as written.
